For this Special Meeting there will be no delegations to Council from the public. At this time there has not been a scheduled date set for the Special Meeting. The Special Meeting is for the purpose of an invitation to the Consultant to present and provide additional information to Council and to provide an opportunity as well for Council to ask questions. I don't know who the Consultant is, but CAO Jason Trottier would have that information.

Once the date of the Special Meeting has been set, notice will be provided on our Municipal Website and the meeting will also be livestreamed.

If you wish to make a presentation to Council regarding the expansion of the pit, you can make a request for a delegation to Council at its Regular Meeting to be held July

12th, 2022. If you choose to make a presentation to Council for July 12th regular meeting, please forward me your request in writing and if you have a presentation prepared, I will require it for inclusion on the agenda. Delegations to Council are limited to a 10 minute presentation. Under the Municipal Procedural By-law No. 2020-17, there shall not be more than 3 delegations entered on the agenda for the meeting. As of now, I have one delegation confirmed from a Council invite to the Nipissing District Social Services Administration Board and there is room for 2 more. Delegations are entered on a first come, first serve basis and at this present time, delegations are still held virtual, there is no public in attendance at the meeting.
