Hello Jill,

Sorry for the delay in getting back to you, but I have received your letter in concern to Maple Lane and Access Road and am following up with the following for your information.

We have look into this matter and to my knowledge, request to maintain accessibility has been identified. As per resolution of October 13, 2015 Council recognized that some of the selected crown lands within the Municipality of East Ferris have multiple private access laneways to permanent residences.

Therefore, the Council for the Municipality of East Ferris requested that the Governments of Canada and Ontario survey and legally transfer, at the Government's cost, all of those private laneways in the land claim area within the Municipality of East Ferris to the Municipality of East Ferris (which will remain privately maintained by the residents) prior to the transfer of Crown lands to the Algonquins of Ontario;

At that time, a copy of this resolution was also forwarded to the elected officials at the time, namely Hon. Kathleen Wynne, Premier of Ontario; the Hon. David Zimmer, Minister of Aboriginal Affairs; the Hon. David Oraziotti, Minister of Natural Resources; Jay Aspin, MP (Nipissing-Timiskaming); Victor

Fedeli, MPP (Nipissing); the Negotiation Team for the Algonquin Land Claim; and, all municipalities within the land claim area.

This resolution was carried by Mayor Vrebosh.


