Municipal Property Assessment Corporation – Board of Directors Position Call for Expressions of Interest

Action: AMO is issuing this call for expressions of interest from qualified municipal elected or municipal staff officials for consideration in building the AMO 2024 list of nominees.

Background: The Municipal Property Assessment Corporation (MPAC) is a not-for-profit corporation that is responsible for providing an accurate and impartial property inventory for our vast province. MPAC is the largest assessment jurisdiction in North America, assessing and classifying more than 5.4 million properties with an estimated total value of \$3.04 trillion. MPAC is accountable to the Province, municipalities and property taxpayers of Ontario through a 13-member Board of Directors.

The Municipal Property Assessment Act, 1997, (section 3) requires that AMO prepare a list each year containing the names of twenty-two municipal officials (current or retired elected or staff officials) for possible appointment as municipal representatives to the MPAC Board. The list is forwarded to the Minister of Finance, who is responsible for appointing members. The Minister of Finance is required to select municipal representatives from the AMO list for appointments and reappointments to the MPAC Board.

In addition to the municipal government representatives, the Minister of Finance also appoints five individuals who represent the interests of property taxpayers ("taxpayer representatives"), and two individuals who


represent the interests of the Province ("provincial representatives"). A list of current appointees to the MPAC Board can be found on the <u>website</u> of Ontario's Public Appointments Secretariate. A number of appointments and or reappointments are expected in 2024.

More information regarding the responsibilities of an MPAC Board member can be found on MPAC's <u>website</u>. The <u>position description for an MPAC</u> <u>director</u>, including qualifications for the position, are posted on the MPAC website.

AMO undertakes a comprehensive renewal of its MPAC nomination list every four years following municipal elections. In assembling the nomination list, the AMO Board will consider candidate qualifications and experience, as well as MPAC's commitment to building an organization that reflects the diversity of the public and communities it serves.
