BEING A BY-LAW TO CLOSE AND CONVEY A VACANT PARCEL OF LAND, DESCRIBED AS CON 3 PT LOT 9 RP 36R6186 PARTS 1 & 2 PCL 15895 WF, EAST FERRIS, DISTRICT OF NIPISSING, LOCATED ON KYLE ROAD, TO THE ABUTTING LANDS DESCRIBED AS CON 3 PT LOT 9 RP NR128 PART 1 PCL 7822 W/F, EAST FERRIS, DISTRICT OF NIPISSING (62 KYLE ROAD).

- That CON 3 PT LOT 9 RP 36R6186 PARTS 1 & 2 PCL 15895 WF, EAST FERRIS, DISTRICT OF NIPISSING hereinbefore described will be conveyed for addition to the adjacent lands being CON 3 PT LOT 9 RP NR128 PART 1 PCL 7822 W/F, further described as 62 Kyle Road and is to be consolidated with the said lands;
- That the Council of the Corporation of the Municipality of East Ferris sets the sale price for CON 3 PT LOT 9 RP 36R6186 PARTS 1 & 2 PCL 15895 WF, EAST FERRIS, DISTRICT OF NIPISSING at \$15,000.00 plus all municipal costs after reviewing an appraisal by Morland Real Estate Appraisals Ltd., dated May 9, 2023;
