

THE CORPORATION OF THE MUNICIPALITY OF EAST FERRIS

BY-LAW NO. 2024-26

BEING A BY-LAW TO AMEND BY-LAW NO. 2023-55 A BY-LAW TO GOVERN THE PROCEEDINGS OF COUNCIL, LOCAL BOARDS AND COMMITTEES OF EITHER, THE CONDUCT OF ITS MEMBERS, THE CALLING OF THE MEETINGS AND TO ESTABLISH RULES OF ORDER.

**WHEREAS** section 238 of the *Municipal Act, 2001*, as amended, provides that every municipality shall pass a Procedure By-Law for governing the calling, place and proceeding of meetings;

**WHEREAS** the Council for Corporation of the Municipality of East Ferris passed By-law No. 2023-55, Being a By-law to govern the proceedings of Council, Local Boards, and Committees of either, the conduct of its members, the calling of the meetings and to establish rules of order, at the regular Council meeting of March 12<sup>th</sup>, 2024;

**AND WHEREAS** the Council for the Corporation of the Municipality of East Ferris passed resolution number 2024-130 at the regular Council meeting of June 11<sup>th</sup>, 2024, approving the recommendation from the Clerk to amend the Procedural By-law to allow for announcements and updates from Council Members;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF EAST FERRIS HEREBY ENACTS AS FOLLOWS:**

1. THAT the Corporation of the Municipality of East Ferris' Procedural By-law No. 2023-55 be amended by renaming Item 6), "Chairs Comments", under Section 7.1 to "Announcements and Updates from Council Members";
2. THAT the Corporation of the Municipality of East Ferris' Procedural By-law No. 2023-55 be amended by adding **Article 7.10 "Items for Inclusion on the Agenda – Announcements and Updates from Council Members"** as follows:

**7.10 Items for Inclusion on the Agenda – Announcements and Updates from Council Members**

This section of the agenda is for Council Members to provide verbal updates regarding announcements of a general nature such as information learned at conferences, community events, and other informational matters that a member would like Council to be aware of. All matters presented under this agenda item are for **information purposes only** and may be submitted in writing to the Clerk for inclusion on the agenda by the deadline or given verbally at the meeting.

3. That all other provisions of By-law No. 2023-55 shall remain in effect.
