8. Public Hearing(s)

a. B-2024-37: Rick Champagne and Nancy Best - 1852 Corbeil Road

A public meeting was held on a consent application submitted by Rick Champagne and Nancy Best. Nancy Best presented the application to the Committee. The purpose of the requested consent is to allow for a lot addition of approximately 9 acres from their property at 1852 Corbeil Road to their neighbours at 1808 Corbeil Road.

Director of Community Services advised that the North Bay Mattawa Conservation Authority had no objections to the application, but there are wetlands near the rear of the property so any future development may require a permit.

Staff have no objects to the application as all minimum requirements are met and neither property would be in contravention of the by-laws.

No public input was provided at the public hearing and the application was approved.

DECISION OF COMMITTEE ON A CONSENT APPLICATION

APPLICANT: Rick Champagne and Nancy Best

CIVIC ADDRESS: 1852 Corbeil Road

FILE NO.: B-2024-37

PURPOSE: The applicant is requesting consent to sever from the Committee of Adjustment for the purpose of a lot addition from 1852 Corbeil Road to 1808 Corbeil Road.

We, the undersigned, in making the decision upon this application have considered whether or not the requested consent is in conformity with the policies laid out in the East Ferris Official Plan and consistent with the requirements of section 51(24) of the *Planning Act*.

CONCUR in the following decision and reasons for decision on the 27th day of November, 2024.

DECISION: That the requested consent for a lot addition be approved, conditional upon the following:

- That confirmation is provided that all taxes are paid up to date;
- That a plan of survey is prepared and filed with the Municipality;
- That a plan of survey be sent electronically to the Municipality of East Ferris's Director of Community Services;
- That the applicant pays \$250.00 in finalization fee per consent application prior to the transfer of the parcel of land;
- That the transfer(s)/Deed(s) of Land is submitted to the Secretary-Treasurer for the Issuance of the Certificate of Consent under subsection 53 (42) of the Planning Act, R.S.O. 1990, c.P.13, as amended;
- That prior to the endorsement of the transfer(s) the owner grants simply
 unto the Municipality of East Ferris free of any charges, all lands
 measured 10.0 metres (33 feet) from the centerline of any existing
 publicly maintained road along the full length of the owner's total holdings
 being the subject of this consent; and
- That all conditions must be filled within two years from the date the notice
 of decision has been given otherwise this provisional consent will lapse
 and the application for consent shall be deemed to be refused as per
 Section 53 (41) of the Planning Act, R.S.O. 1990, c.P.13, as amended.
