RECOMMENDATION

That tender EF 2019-04 for granular materials in the amount of \$187,139.30 including H.S.T. be awarded to Evan Hughes Excavating for the 2019 construction season.

BACKGROUND

Tender EF 2019-04 Granular Material was advertised in the North Bay Nugget on Saturday, April 27th, 2019. The Tender closed on May 8th, 2019 at 3:00 p.m. and was opened after 3:15 p.m. in the East Ferris Municipal Garage in the presence of Deputy Mayor Mr. Mike Voyer, Councillor Mr. Steven Trahan, Clerk Monica Hawkins, Kari Hanselman Deputy Clerk, Director of Public Works and Engineering Antoine Boucher and Road Foreman Marius Robidas. Member of the public included Melissa Hughes – Evan Hughes Excavating, Brandon Boyer – Pioneer Construction, Rick Champagne – Champagne Aggregate, Jodie Geisler and Bylan Young - Miller Paving North Bay and Derek Watson – Watson Landscaping.

Nine (9) tender packages were picked up and a total of six (6) bids were received. No addendums were issued.




