## Reports:

a) Presentation received from Glenn Brophey and letter from Mike Pettigrew from per Council meeting of April 23/19. Director of Public Works is to prepare report regarding One Mile Road:

Mr. Glenn Brophey and Mike Pettigrew attended the Public Works Committee Meeting. Discussion took place regarding Mr. Brophey's presentation and Mr. Pettigrew's letter that was presented at Council Meeting April 9<sup>th</sup>, 2019. Municipal Engineer advised Mr. Brophey and Mr. Pettigrew that he was in the process of working on a report regarding this matter. It was unclear if the report would be ready for Council meeting of May 28<sup>th</sup>, 2019. Clerk advised they were also welcome to contact her in order to find out.

Prior to the Public Works meeting, Councillor Trahan went over and had a look at One Mile Road. Antoine advised that in order to make this road to municipal standards, the road would have to be brought to a standard 2 lane road, which is presently now a one lane road. The road needs a lot of work. This road would have to be done in two phases. First phase would be costly and second phase would be a much greater amount. There was concern as well with recycling and garbage as to bringing it to the maintained road. Engineer advised that this could be looked at when the subdivision is in place.

Municipal Engineer advised Mr. Brophey and Mr. Pettigrew that he will prepare his report in a timely manner, but to keep in mind that the report would be only an Information Report and at this time not a recommendation

to Council. There are many studies to be done prior to a recommendation to be made. Mr. Brophey and Mr. Pettigrew advised that they understood the process.

- b) Letter received from Ted McCullough concerning Quae Quae Road litter and requesting sign. (pictures as well) Antoine advised that it would be a minimum cost to put a sign up regarding littering. Councillor Trahan stated that he would go over and see Mr. McCullough
