PUBLIC HEARING:

**a) A-2019-06
Lisa McNeil**

A public meeting was held on an application submitted by Lisa McNeil.

The applicant's proposal requested a variance to permit the use of the property for rural uses as defined in the Agricultural Zone provisions of the By-law; whereas rural uses are currently not permitted on the subject property.

Staff and the NBMCA were in support of the application and no other comments were received. The NBMCA included a Minimum Distance Separation Calculation sheet that was supportive of a hobby barn on the subject property. They indicated that manure storage location should be clarified; however, it appeared that there was sufficient space to easily accommodate the request.

The application was approved as requested.

A public meeting was held on an application submitted by Barb Fisher.

The applicant's proposal requested a variance to permit an increase in the allowable lot coverage from 10% to 13% for the construction of a single-family dwelling with attached garage.
