DELEGATIONS

Guy Fournier, representing the Corbeil Country Ribfest Committee, presented a delegation to the Committee requesting a reduced fee for the 2020 Corbeil Country Ribfest to host the event at the East Ferris Community Centre. The event will take place on July 5th, 2020 and set up will be required on July 4th, 2020. Regular rental fees would be approximately \$1900.00 including HST. It is the position of the Corbeil Country Ribfest Committee that reduced rental fees would increase the profits and available funds that would be dispersed back into the community.

After discussions it was determined that further information is required to approve or deny the request. The item is deferred to a future Special Meeting of the Parks, Recreation and Culture Committee, on a date to be determined once the information is obtained by Tom Slack, Manager of Recreation and Facilities.

Soccer Registration Fees 2020

NEW BUSINESS

Soccer Program Relocation for 2020

Recreation Programs and Events Coordinator, Tammy Borgen-Flood advised the committee that the East Ferris and Callander Youth Soccer Program will utilize the soccer fields in Callander at Yarlasky Park, for the soccer program in 2020, due to the construction at the Municipal Office in Corbeil. The site in Callander has adequate storage, washroom facilities and will be maintained by Callander Municipal Staff with support from Municipality of East Ferris staff.

Volleyball Program Relocation for 2020

Tom Slack, Manager of Recreation and Facilities advised the Committee that Municipal staff are currently working on assessing alternate locations to host the Volleyball Program in 2020, due to construction in Corbeil. They are also consulting with the coordinator of the Volleyball Program. Viable options will be presented to the Committee at a future date for discussion.

Community Better Challenge 2020

Recreation Programs and Events Coordinator, Tammy Borgen-Flood advised the committee that the Municipality of East Ferris will be coordinating the Community Better Challenge on behalf of the Municipality for 2020. A comprehensive strategy and implementation plan are currently being drafted and will be shared with the committee at a future date.
