#### 9. General Follow Up/Roundtable Discussion

Mr. Paquette reminded the Committee of the BTIF (Business Technology Improvement Fund) and CTAF (COVID-19 Technology Adoption Fund) which are available to businesses. Mr. Kirton advised he has shared the funding information via the East Ferris Business Community Networking Facebook page and that the Municipality has applied for funding under the CTAF program.

Mr. Clouthier requested an update on the snowmobile trails. Councillor Trahan advised he has been in contact with a property owner and Mr. Sears. They will walk the potential site in October. Mr. Kirton has given Mr. Sears some mapping information. Mr. Paquette asked whether there were possible tax breaks for landowners who make their land available for snowmobile trails. Mr. Kirton will look into it and report back to the Committee.

After brief discussions, a resolution deferred from the last meeting was carried. The intention is to get clearer direction from Council on how to engage with potential investors in the future.
