

## PUBLIC WORKS COMMITTEE MEETING May 17th, 2021 at 1:00 p.m. Virtual - ZOOM

- **2. Minutes of previous meeting, April 22nd, 2021** (circulated on Council agenda of May 11th, 2021) Approved as circulated to Council.
- 3. **Declarations of Conflict of Interest** None for this session
- 4. Correspondence and Information Items:
  - a) Director of Public Works: Update on Lake Nosbonsing Road starting after the May Long Weekend and is expected to be complete by late June.
    - Director of Public Works advised that Pioneer Construction will start after the May long weekend and will be complete by mid June. From there the municipality will complete the shoulder work and have the line painting done
  - b) DRAFT Littering By-law for committee review:
    - Committee reviewed the Draft Littering By-law. Chair will meet with Director to discuss further. The Littering By-law is referred to the next Public Works Committee meeting
  - c) Letter from Carole Orris Maintenance re Gauthier Road
    - Committee discuss Ms. Orris letter. Gauthier Road is a private Road and not maintained by the Municipality. Chair and Co-Chair advised that they will be discussing this at the Regular Meeting of Council to be held May 25th, 2021 and advised the Director to be present for this discussion.
  - d) Dan Lyle, Active Transportation -
    - This matter of discussion did take place at a Council meeting. Council
      advised that if opportunity arise for funding for paved shoulders/walkways,
      the municipality will apply in conjunction with neighbouring municipalities.
