- b) **Ministry of the Solicitor General**: Review of Court Security and Prisoner Transportation This was for information to the Committee. Page 69 gives a summary of the cost. St. Sgt McMullen mentioned that the young offenders that are held in custody, are transported to Sault-Ste-Marie or Thunder Bay, this taken time and cost. St. Sgt. advised that this is more of a political issue then a Ministry issue and this is something that should be addressed to our MPP. St. Sgt. McMullen will be forwarding document to PSB Chair, Pauline Rochefort.
- c) Antoine Boucher Correspondence re Active Transportation Signs Director of Public Works discussed with the Board various signs at the three-point entry of the municipality.
