## 6. Updates/New Business

### 6.1 Tradeshow Updates – Natasha Penn

Natasha let the committee know that sponsorships have doubled this year already than in previous years with a total of \$11,500 sponsorships. There are 46 vendors with 49 secured booth spaces. Booth registrations typically close May 13<sup>th</sup> so they can make a floor plan but will always allow for last minute booths.

# 6.2 Economic Development Strategy Updates – Natasha Penn

Natasha let the committee know that we had 96 responses with the survey and they went through the results. Next steps are to prepare a draft Economic Development Strategy to finalize and approve. The results of the Economic Development Strategy Survey will be shared with the Economic Development Committee after they are presented to Council.

# 7.1 Animal Control By-law Revisions 7.1.1 Council Resolution and Public Comments Attached

Council discussed the Animal Control By-law Amendments following the public consultation period and decided to forward the comments back to the Economic Development Committee for their consideration and further review. Council is looking for an updated recommendation from the Committee based on then public comments received.

Mr. Kirton mentioned three main points to look at for revisions;

- Are the number of chickens per acre appropriate?
- Clarify definitions
- Lot size requirements

Mr. Kirton will write up some amendments in the next month to go over with the committee prior to the regularly scheduled July meeting.

### 7.2 Draft Short Term Rental By-law Comments

The committee discussed the proposed short term rental by-law and the comments received and passed the following resolution.

Whereas the Economic Development Committee is generally in favour of the Draft Short Term Rental By-law and recognizes the need to regulate Short Term Rentals in East Ferris.

And Whereas the Economic Development Committee recommends to Council that the by-law go forward generally as written, with the exception of considering the fee structure. The committee feels that higher fees may be warranted and recommends that Council consider the fee structure prior to passing the by-law.
